Sitting on 800 acres in the Pioneer Valley of Massachusetts, Mount Holyoke is a residential, research liberal arts college for women. The first of the Seven Sisters, the College serves 2,300 undergraduate students in 50 majors and employs 240 faculty and 1,000 staff. My presidency was marked by a robust strategic planning process; outreach to local and regional communities; engagement with a world-wide network of Mount Holyoke's 34,000 alumnae; and a commitment to a vibrant campus community. As the CEO, I oversaw a \$717m endowment and \$128.4m annual operating budget, reporting to a 31-member Board of Trustees.
